**Subject: -** Petition of The Tata Power Company Limited – Generation under Section 11 of the Electricity Act, 2003 read with Section 86(1)(h) and 86(1)(k) of the Electricity Act, 2003 along with Regulation 101 and 102 of the Maharashtra Electricity Regulatory Commission (State Grid Code) Regulations 2020 including amendments thereto and all enabling powers in this regard including the inherent powers and expansive regulatory authority vested unto the Hon'ble Commission, thereby seeking this Hon'ble Commission to consider relaxation/ amendment/ modification in Maharashtra Electricity Regulatory Commission (State Grid Code) Regulations 2020 for enabling power sale by generator.
