MAHARASHTRA ELECTRICITY REGULATORY COMMISSION

REQUIRES

Senior Regulatory Officer (Technical), Regulatory Officer (Technical) and Stipendiary Regulatory Analyst (Technical) on Retainership cum Consultancy – Contract for 33 Months/3 Years

Introduction:

The Govt. of Maharashtra, vide Notification dated August 5, 1999, set up the Maharashtra Electricity Regulatory Commission (MERC) consisting of a Chairperson and two Members under the Electricity Regulatory Commissions (ERC) Act, 1998. The Commission has three-fold functions, viz. (i) quasi-judicial; (ii) quasi-legislative and (iii) executive. The following functions were initially entrusted to the Commission under that Act:

- a) Determination of the Tariff for electricity wholesale, bulk, grid or retail, as the case may be;
- b) Determination of the Tariff payable for the use of the transmission facilities;
- c) Regulation of power purchase and procurement process of the transmission and distribution utilities, including the price at which the power is to be procured from generators or other sources for transmission, sale, distribution and supply in the State;
- d) Promotion of competition, efficiency and economy in the activities of the electricity industry to achieve the objects and purpose of the Act.

Consequent to the coming into force of the Electricity Act (EA), 2003 from 10 June 2003, the ERC Act was repealed and the Commission was entrusted with the following additional functions:

- a) Facilitation of intra-State transmission and wheeling of electricity
- b) Issue of Licenses to for electricity transmission, distribution, and trading
- c) Promotion of cogeneration and generation of electricity from renewable sources of energy
- d) Adjudication of disputes between Licensees and generation companies, and between Licensees, and reference of any dispute for arbitration
- e) Levy of fees for the purposes of the Act
- f) Specification of the State Grid Code
- g) Specification or enforcement of standards with respect to quality, continuity and reliability of service by Licensees
- h) Fixation of trading margin in the intra-State trading of electricity, if necessary
- i) Discharge of such other functions as may be assigned under the Act
- j) Advice to the State Government under Section 86 (2).

Degree in Electrical / Electrical & Power Engineering, Power System Engineering from a recognized University.

(B) Desirable: -

Post Graduate in Electrical Engineering/Power Systems or MBA in (Financial Management / Power Management) from any AICTE approved University / Institute, will be given preference.

(2) Experience: -

(A) Essential: -

Minimum 5 years post qualification experience in works related to Power Purchase Agreements, Renewable Energy, Tariff Determination process, and Transmission, in Power Sector / Electricity Utility / Licensee.

(B) Desirable: -

Candidates having Experience in Regulatory Commission will be given preference.

(3) Age Limit: -

The Maximum age limit for the candidate should not be more than 45 years as on date of publication of Advertisement. The upper age limit will not be applicable for a person who has at least three years of experience of working in the MERC.

(4) Remuneration:

Rs. 75,000/-per month (Consolidated all inclusive).

(B) Desirable: -

Post Graduate in Electrical Engineering/Power Systems or MBA in (Financial Management / Power Management) from any AICTE approved University / Institute, will be given preference.

(2) Experience: -

(A) Essential: -

Minimum 3 years post qualification experience in Power Sector / Electricity Utility / Regulatory Commission.

(B) Desirable: -

Candidates having experience in Generation, Transmission, Distribution, Renewable Energy and Energy Efficiency, and ability in Economic Analysis, Modeling and Statistical techniques, will be given preference.

(3) Age: -

The Maximum age limit for the candidate should not be more than 40 years as on date of publication of Advertisement. The upper age limit will not be applicable for a person who has at least three years of experience of working in the MERC.

(4) **Remuneration:**

Rs.60,000/- per month (Consolidated all inclusive).

(3) Age Limit: -

The maximum age limit for the candidate should not be more than 35 years as on date of publication of Advertisement.

(4) Remuneration:

Rs. 30,000/-per month (Consolidated all inclusive) for First Year Rs. 40,000/- per month (Consolidated all inclusive) for Second Year Rs. 50,000/- per month (Consolidated all inclusive) for Third Year
