Subject: - Petition of Captive Power Producers Association seeking amendments in existing Regulations for establishing and operating wind-solar-thermal hybrid power plant in line with the National Wind-Solar Hybrid Scheme, 2018 and the MoP scheme for Flexibility in generation and scheduling of thermal/hydro power stations through bundling with renewable energy and storage power.
