(Petition of Maharashtra State Electricity Distribution Company Limited (MSEDCL) for seeking approval on adoption of tariff for procurement of 13 MW of wind-solar hybrid power through green shoe in respect of MSEDCL's tender for procurement of 2000 MW wind-solar hybrid power with greenshoe option of additional capacity upto 2000 MW through competitive bidding under Section 63 of the Electricity Act 2003 for meeting the wind and other renewable purchase obligations.)
