<u>Subject: -</u> Petition of Ghatge Patil Industries Limited seeking waiver of fixed demand charges, reduction of Contract Demand and relaxation under MERC (Distribution Open Access) Regulations, 2016 on the banking issue due to Force Majeure situation prevailing in Maharashtra State due to COVID-19 outbreak

- 1. The Hon'ble Appellate Tribunal for Electricity (APTEL) has passed Judgment dated 22 October, 2024 in Appeal No. 148 of 2020 and remitted the matter to the Commission for passing afresh Order. The excerpts of the Hon'ble Appellate Tribunal for Electricity (APTEL) Judgment are as follows: -
 - "16. In view of the above noted peculiar and unacceptable approach adopted by the Commission in arriving at decision in the instant case, we are unable to sustain the impugned order. The same is absolutely erroneous and is hereby set aside. Accordingly, the appeal stand allowed.
 - 17. The case is remanded back to the Commission with direction to hear the parties again and pass a fresh order within two months from the date of this Judgment."

Failure of the Parties to appear before the Commission on the date of e-Hearing, the Parties shall be a sole responsible for its cause and consequences.
