

**PUBLIC NOTICE**

**Inviting Suggestions/Objections on Adani Electricity Mumbai Limited's (AEML-T)  
Application for 5<sup>th</sup> amendment of its Transmission Licence No. 1 of 2011 (Case No.159 of 2024)**

1. The Adani Electricity Mumbai Limited - Transmission Business (AEML-T) has filed an Application for amendment of its Transmission Licence No.1 of 2011 before the Maharashtra Electricity Regulatory Commission under the provisions of Section 18 of the Electricity Act, 2003 and MERC (Transmission Licence Conditions) Regulations, 2004. The Commission has admitted the Application on **4<sup>th</sup> December, 2024** and directed AEML-T to publish a Public Notice under Section 18 (2) of the Act.
2. Rationale for proposed alteration or amendment:  
Licence issued to AEML-T is asset specific, which means that it authorizes AEML-T to create, operate, and maintain assets that are specifically identified in the Licence. Since, AEML-T is not operating any specific transmission project, but it is a Transmission Licensee for multiple transmission lines/assets, there is a need to regularly update the specific transmission assets (lines and bays) mentioned in the Licence, as and when new systems are created or existing systems are removed or modified or more systems are proposed to be added. Further, the Commission in the Order dated 13<sup>th</sup> March, 2021, in Case No. 195 of 2019 had issued direction to AEML-T that in future AEML-T shall propose the schemes to be added in its Transmission Licence which are essential for the system and are included in the STU plan. Accordingly, AEML-T has proposed amendments to its Transmission Licence.  
The amendment in the Licence is proposed as under:
  - Existing System, both - Transmission Lines and Bays - is as per actual physical network
  - Proposed System, both - Transmission Lines and Bays - is based on:
    - Already approved DPRs by the Commission, for which the scheme is under execution/proposed to be executed
    - State Transmission Utility (STU) ten year plan from FY 2024-25 to FY 2033-34, which includes the future schemes identified by STU to be developed by AEML-T
3. The Commission has directed AEML-T to invite Suggestions/Objections from the Public on its Application for amendment of Licence through this Notice. Contact details of the nodal person from whom a copy of the Application may be obtained for inspection or purchase is as under:
