**Terms Of Reference**

1. The Vendor has to place their Printers in the office of the MERC.
2. The selected Vendor shall be responsible for maintenance service of printers including Cartridges / Toners and kit/parts free of cost but excluding papers.
3. The contract will be valid for a period of 3 years.
4. The rates quoted will remain in force for the full period of the contract. No demands for revision of rate, by the Vendor, shall be entertained during the contract period.
5. Printers reading shall be recorded by the Vendor at each month end and same will be counter signed by MERC officer.
6. MERC shall not be responsible for the item placed for any damages to the same. It shall be sole responsibility of the service provider; however, MERC shall provide man power for its operation and daily running. He/she is to be trained and certified by the service provider.
7. In case of Printer giving frequent issues after installation during the contract period, it will be the responsibility of the Selected Vendor to change the Printer with same or higher configuration Printer.

8. Right to Award Tender: MERC reserves the right to award tender to any other agency, as and when felt necessary, who may not be a bidder without assigning any reason, at the same rate, terms & conditions to which this tender shall be finalized.
9. MERC reserve the right to terminate the Contract by giving 30 days notice, if the service is found unsatisfactory. The bidder to whom the tender has been awarded against this tender shall not be entitled to any compensation or consideration in any of such events.
