3. Test Run/Mock Trial is being conducted for handholding these speakers about e-hearing process. Test Run will also help to verify whether facilities available at speaker end are adequate for smooth participation on E-Public Hearing Platform. In case it is found that facilities at speaker's end are not adequate, then such speaker has to participate in e-public hearing from MERC E-Facilitation Centre set-up at 'District Planning Committee, Behind Sadar Police Station, Nagpur' on 4 March 2025 at 10.30 am.
4. It would not be possible to test the adequacy of facilities for a person who does not participate in Test Run/Mock Trial. Therefore, such a person shall preferably participate in e-public hearing from MERC E-facilitation Centre. In final list for E-Hearing, such person shall be considered for participation from 'E-Facilitation Centre'. However, they may participate from their own facility on their own risk.
5. Kindly note that person who have opted for 'wish to speak' from 'MERC Facilitation Centre' or submitted suggestions and objections in hard copy and expressed 'Wish to Speak' need not undertake Test Run/Mock Trail. These persons need to attend E-Public Hearing from MERC Facilitation Centre on date of E-hearing.
6. After completing Test Run/Mock Trial, final list of speakers for E-Hearing Scheduled on 4 March 2025 will be published on MERC Website.
