**Subject: -** Non compliance of the Commission's Order dated 27 December 2024 in Case No. 12 of 2024 by Maharashtra State Electricity Distribution Company Ltd. (MSEDCL).

(Petition of MSEDCL seeking review of Order dated 08<sup>th</sup> January 2024 passed in Case No. 181 of 2023 in the matter of non-compliance of regulation 22.14 & 25.2 of the MERC (supply code and standards of performance of distribution licensees including power quality) Regulations, 2021 regarding installation of power quality meters and mechanism for automatic compensation.)

1. The Commission in MERC Case No. 12 of 2024 has issued Order dated 27.12.2024 and has issued notice dated 24.01.2025 for non-compliance of the said Order, MSEDCL has filed reply dated 05.02.2025 to the notice. The Commission has scheduled hearing on the issue of non-compliance of the Commission's Order within time.
2. I am directed to communicate that the Commission has scheduled e-Hearing in this matter on, **Tuesday, 11 February, 2025 at 10.30 AM**. MERC – IT Team will communicate the credentials for login into e-Hearing Application and will also provide assistance for using this Application.
4. In case of technical constraint of Video-Conferencing platform, credential for login will be given to one or two persons only. All others can attend the e-Hearing through live streaming link provided on website of the Commission.
5. Documents to be referred during the e-Hearing shall be uploaded on 'Petition E-filing Portal' only, at least two days before the scheduled e-Hearing for reference of the Commission and all concerned parties. During the e-Hearing, parties shall refer these uploaded documents only.

6. All communication related to e-Hearing shall be made on 'ehearing@merc.gov.in' mentioning MERC Case number.
7. NOTICE is hereby given to you to attend e-Hearing through video conferencing through an authorized functionary or duly authorized advocate before this Commission on said date and time.

TAKE FURTHER NOTICE that if you fail to appear on the said date and time, the matter will be heard in your absence on the said date or any subsequent date to which the matter may be posted, as directed by the Commission, without any further notice. Failure of the Parties to appear before the Commission on the date of e-Hearing, the Parties shall be a sole responsible for its cause and consequences.
