The Hon'ble Bombay High Court by its order dated 13.10.2011, interalia stayed the Maharashtra State Information Commission's order dated 14.03.2011 Adani Electricity Mumbai Ltd. being not a 'public Authority' as defined under the provisions of Section 2 (h) of the Right to Information Act, 2005.  Therefore, transfer of application under Section 6 (3) of RTI Act, 2005 is not required.
