Heard the Representative of the Petitioner, Advocate and the Representative of the Respondent, Advocate of the Intervener and the Consumer Representatives in person, present in the Court.

Both the parties are directed to submit copies of the presentations made by them on affidavit with a copy served on each other, the Intervener and the Consumer Representatives. The Respondent, TPC is directed to look into the operational issues (particularly the connections given to Consumers in arrears and disconnected Consumers) raised by the Petitioner and resolve the same in a time bound manner. The Respondent is allowed to raise their operational issues with a copy served on all the parties. The Respondent is further directed to submit tariff slab wise (i.e. BPL, 0-100 units etc) details for change over consumers in Residential category.

This Commission notes that interim Order dated 15<sup>th</sup> October 2009 was the outcome of the non-adversarial approach of both the parties and the Commission expects the same support from both the parties. Both the parties are directed to file their submissions on the possible solutions for managing the transition, with a copy served on the other parties. The Petitioner is further directed to submit zone wise consumers and sales mix, with a copy served on the other parties.

Post the matter for further hearing on Friday, 13<sup>th</sup> April 2012 at 11.00 hrs. All the aforesaid pleadings are to be completed before the next date of hearing.
