1. Study of MSEDCL's Circular No. 175 and 177 and suggest modification required in these Circulars to make it inconsonance with Tariff Order dated 16 August 2012 (case No 19 of 2012).

2. Study of following documents and summarise the same issue-wise in tabular format:
 - a. Show Cause Notice dated 21 December 2012.
 - b. MSEDCL's reply dated 24 January 2013.
 - c. Petitioner's rejoinder dated 8 February 2013.
3. Study of Tariff Schedule approved by the Commission in Tariff Order dated 16 August 2012 and prepare comparative chart of tariff payable by various category of consumers.
