**Daily Order**

Heard the Petitioner, the Respondent and Dr. S.A. Soman of IIT Bombay.

The Commission directs the Petitioner to submit detailed chronology of construction activities of its power plant which should include the installation of meters and bus reactor.

The Commission directs the Respondent, MSEDCL to submit the following:

- a. The practice being followed in respect of startup power consumption of all Generating Plants in its area of supply. Plant wise details needs to be submitted.
- b. Check the provisions of PPA signed between the Petitioner and the Respondent and confirm that present practice of levying Commercial Tariff to the Startup power consumption is in line with provisions of PPA.
- c. Submit financial implications of the Petitioner's prayer 'b' and 'c' on MSEDCL.
- d. Suggest alternatives to treat startup power consumptions of the Generating Plant along with financial implications of each such alternative and also submit the priority of such alternatives.

All above submissions to be made within one week with copy to be served on all parties.

MSEDCL not to take any coercive action in this matter.
