**Daily Order**

1. Heard the Petitioner, the Respondent and the Representatives of the Government of Maharashtra.
2. It has been submitted that the Government of Maharashtra (GoM) vide GR dated 9 December 2013 has constituted a committee. The first meeting of the said Committee was held on 6 January 2014 and next meeting is scheduled on 20 January 2014.
3. The Commission noted that the GoM while constituting the above said Committee has changed the composition of the Committee ordered by the Commission in its Order dated 21 August 2013.

4. The Commission asked the Petitioner to state the reasons for modifying the composition of the Committee setup under the Order dated 21 August 2013 of this Commission. It appears prima-facie a violation of the Commission's Order. The Commission asked the Petitioner for clarification thereof especially in view of fact that an identical composition was approved by GoM in CERC's Order in the Petition No. 159/MP/2012.
5. The Commission directs that till such time the above said clarifications are received, the composition of the above said Committee setup pursuant to the GR dated 9 December 2013 should be partially modified to include the Representative of the APML as a permanent invitee with access to the documents and deliberations of the Committee.
6. MSEDCL is directed to file an affidavit within three weeks.
7. The Secretariat of the Commission will communicate the next date of hearing in this matter
