The Advocate of the Respondent submitted that MSEDCL vide letter dated 3 March, 2014 informed the Commission that MSEDCL has refunded one month AEC and additional FAC of 1198 consumers, amounting to Rs. 2461.22 Lakh in the billing month of February 2014, where an error in the applicability of AEC had taken place, and requested to dismiss the cases as nothing survives in the matter.

Since, the Petitioners were also not present at the Hearing, the Commission dismissed the Cases.
