Heard the MSEDCL, APML and Authorised Consumer Representatives.

Shri. Avinash Anurag of SBI Capital made presentation on the Report of the Committee on Compensatory Tariff for Tiroda power plant of Adani Power Maharashtra Limited.

MSEDCL requested time for submitting their reply on APML's submission dated 26 March, 2014. Authorised Consumer Representative mentioned that copy of submissions made by both parties have not received to them and further requested time for submission of their reply after receipt of submissions of both the parties.

Having heard, the Commission directed as follows:

- a. Both parties to serve copy of their submissions on authorised Consumer Representatives.
- b. Both the parties to quantify the impact of Committee Report based on their views on the principles/assumptions used in Committee Report. Such quantification for indicative purpose should be done based on the prevailing conditions as on 21 August 2013 i.e. date of Order in Case No. 68 of 2012. The said quantification along with the detailed justification should be submitted by 10 April 2014 with copy served on Authorised Consumer Representatives.
- c. As agreed, Shri. Ashok Pendse, Authorised Consumer Representative is requested to suggest options / mechanism for compensating hardship being faced in present case.
