Daily Order

Heard the Advocates for the Petitioner and Representatives of the Respondents.

The Commission noted the information submitted by the Petitioner on the interruption of power supply to consumers for the period 7 March, 2014 to 10 April, 2014 in the supply area of the Petitioner and asked the Respondent No. 1, AMNEPL to confirm the same. The Respondent No. 1, AMNEPL confirmed that there have been some interruptions.

The Respondent, AMNEPL, informed the Commission that a meeting has been scheduled for tomorrow, i.e., 12 April, 2014, regarding the supply of power to the Petitioner. AMNEPL further requested for adjournment of hearing as AMNEPL did not get time to prepare its submission as 10 April, 2014 was declared public holiday and hence sought time for its submission in the matter. The Commission agrees with the request of AMNEPL that time needs to be given to them to make submissions in the matter. However, based on the statistics on interruptions provided, the Commission is of opinion that there is a emergent situation for which ad-interim arrangement

should be in place for providing uninterrupted supply to consumers including continuous process Industries. The Commission further rules that AMNEPL shall be provided with an opportunity of being heard in the next hearing.

The Commission enquired MSEDCL regarding its preparedness to supply the power to the consumers in the MADC area, to which MSEDCL confirmed the availability of power and its readiness to supply at the earliest.

After hearing all the parties, the Commission directed as under:

- (a). MADC, AMNEPL and MSEDCL should ensure the consumers in the MADC area should get un-interrupted power supply.
- (b). Respondent No. 1, AMNEPL to start supplying minimum 80% of the committed supply of power starting from 2 p.m. today, i.e., 11 April, 2014, which AMNEPL has agreed during the Hearing and the Commission asked them to submit it in writing.
- (c). MADC and AMNEPL to communicate the outcome of the meeting in writing by 12:00 Hrs tomorrow, i.e., 12 April, 2014 to the Commission.
- (d). In case AMNEPL is not able to provide uninterrupted power supply as per agreement to the consumers, MSEDCL should start supplying power to such consumers who have applied to them. MSEDCL may use the transmission/distribution network of AMNEPL and MADC, wherever necessary.
- (e). The technical details of actual management of transmission, distribution and associated system belonging to AMNEPL and MADC shall be settled between 3 parties (MADC, AMNEPL and MSEDCL). Appropriate charges for use of assets shall be decided subsequently.

Next date of hearing shall be communicated by Secretariat of the Commission.
