**Daily Order**

Heard Advocates and Representatives of the Petitioner and Respondent.

The Petitioner during the hearing pointed that MSEDCL has not complied with directives of the Commission in Daily Order dated 3 December, 2013 and it has not received any copy of submission by MSEDCL in this regards.

The Commission observed that the representative from MSEDCL was not aware of its submission dated 28 February 2014 which was done for complying with the directives of the Commission and the copy of the reply was also not sent to the Petitioner.

The Commission expressed its displeasure on lackadaisical approach of MSEDCL towards compliance of directives of the Commission in Daily Order dated 3 December, 2013. The Commission directed MSEDCL to assign a nodal officer for dealing matters pertaining to compliance of the directives of the Commission and the designated nodal officer should be present in every hearing of the Commission.

The Commission directed the Secretariat of the Commission to draft a letter to be sent to the Chief Secretary, Government of Maharashtra (GOM) under the signature of Chairperson for expressing the displeasure of the Commission for non-compliance of its directives.

The Commission further directed the Principal Secretary to write a separate letter to the Principal Secretary, (Energy), GOM, to convey the Commission's concerns and displeasure over MSEDCL's lackadaisical approach towards compliance of directives of the Commission in Daily Order dated 3 December, 2013.

MSEDCL is directed to serve the copies of submissions made on 28 February, 2014 to Petitioner and to make additional submission, if any, by 30 April, 2014.

Petitioner is directed to submit its rejoinder, if any, by 2 May, 2014.
