The Commission directs as follows:

- a. Implead BEST Undertaking and Tata Power-Distribution as a parties in the present matters

- b. Implead Government of Maharashtra through the Principal Secretary (Energy), the Principal Secretary (Planning) and the Principal Secretary (Finance) as a party in the present matters.
- c. Both the Petitioners are directed to serve the copy of their respective Petition on above impleaded parties.
- d. The Commission will like to have response of the Govt. of Maharashtra on the draft Roadmap to reduce Cross subsidy which was submitted by the Commission for consideration of the Government on 21 June 2012.
- e. All Distribution licensee to rework their proposal by taking into account the methodology proposed by the Commission in above said Roadmap
- f. RInfra to submit detailed submission demonstrating that present matter can be proceeded with even though appeal filed by RInfra in Appeal No 178 of 2012 related to Cross subsidy surcharge is pending before the Hon'ble Appellate Tribunal.

Post the matter **for hearing on Friday, 8 February, 2013 at 1100 hrs.** Meanwhile all parties to submit the above details well before next date of hearing with copy served on each other and Consumer Representatives.
