### **Daily Order**

Heard the Representatives of Petitioner, Respondents and Consumer Representative.

The Commission noted that MADC has submitted its 3<sup>rd</sup> addendum to the Petition on 13 November, 2014 and Respondents did not have time to respond to the same. However, in the interest of the consumers of MIHAN SEZ, the Commission heard the matter.

The Commission directs MADC to file affidavit by 17 November, 2014 with the following submissions:

- a) To submit its stand on the "notice of termination" of Concession Agreement issued by AMNEPL
- b) Proposed long term power procurement plan for MIHAN SEZ
- c) Transmission cost of network of AMNEPL
- d) Details of other allied Distribution costs to supply power to consumers of MIHAN SEZ

The Commission allows MADC to initiate steps for power procurement from alternate source. The said approval of the Commission is subject to submission of MADC affidavit on 17 November, 2014.

The Commission directs AMNEPL to file its rejoinder and also submit the transmission charges for using its network, by 17 November, 2014.

As agreed, Shri. R.B. Geonka of VIA may submit possible long term solutions to get cheaper power to consumers of MIHAN SEZ within 15 days.

Next date of hearing will be communicated to the parties by the Secretariat of the Commission.
