Advocate of MSEDCL mentioned that MSEDCL is withdrawing the addendum application dated 6 August, 2015 filed in present matter with liberty to file it separately, which was agreed to by the Commission.

Advocate of MSEDCL argued in support of admissibility of review Petition. Shri Ashish Chandarana opposed the admissibility of the review Petition. On the Miscellaneous Application No. 5 of 2015, filed by Shri. Ashish Chandarana requesting certain documents, MSEDCL mentioned that they are not denying any documents but will like to restrict it to the legal requirement of present Case. The Commission directed MSEDCL to file its reply on MA No. 5 of 2015 within seven days with copy served on the applicant.
