Daily Order

Heard the Representatives of the Petitioner and Respondents.

Petitioner submitted that it has filed an application for Open Access to R-Infra on 2 April, 2014 and to MSEDCL, as generator is connected to MSEDCL distribution Network, on 21 May, 2014. Accordingly, MSEDCL issued Open Access to the Petitioner with effect from 1 June, 2014 instead of 1 April, 2014, delayed by two months.

Petitioner submitted that SLDC has refunded the amount collected against scheduling charges in monthly bill. Hence, there is no issue pending with SLDC .The Petitioner further, submitted that R-Infra has delayed giving effect of Generation Credit Notes (GCN).

R-Infra submitted that it gives effect of GCN in the monthly bill of consumer when energy injected is credited by SLDC in the FBSM to R-Infra.

However, as per submission of SLDC and discussion held in "Open Access Monitoring Committee" meeting, on 10 July, 2015, it has given effect of 4 months GCN (March, 2015 to June, 2015) in the energy bill of July, 2015.

Petitioner submitted that he has not received any such bill.

Petitioner requested to allow 10 days time to file Rejoinder to Reply submitted by R-Infra and MSEDCL. Accordingly, the Commission has directed Petitioner to file its Rejoinder on affidavit within 10 days.

Further, the Commission has directed R-Infra to submit the procedure for adjustment of GCN in the consumer's monthly bill by Thursday, 13 August, 2015.

Next date of hearing will be communicated by the Secretariat of the Commission.
