**Daily Order**

Heard the representatives of the Petitioner.

Representative of the Petitioner re-iterated the submissions in the Petition and requested to take on record the deemed Distribution Licensee status of the Petitioner and issue the specific conditions of Distribution Licence applicable to it.

The Commission observed that vide approval letter dated 7 February, 2012 issued by Ministry of Commerce and Industries, Department of Commerce (SEZ Section), Government of India, the Petitioner, M/s Flagship Developers Pvt. Ltd. has been approved as a co-developer for development of facilities over an area of 5 Hectares and not the entire SEZ area of 10.17 Hectares and directed the Petitioner to clarify the same. The Petitioner submitted that the necessary clarification alongwith the relevant document shall be submitted for the consideration of the Commission.

The Commission directed the Petitioner to submit details of the ownership and development rights, and also the following:-

- a. the Plan to meet the obligations and discharge the duties as Distribution Licensee as per the provisions of the Electricity Act, 2003 and Rules and Regulations made thereunder

- b. Timelines to further activities such as PPA filing, ARR filing, CGRF establishment etc.
- c. The map duly certified by the competent authority, i.e. Development Commissioner (SEZ), indicating the notified SEZ Area.

The Petitioner is directed to file its revised Petition within 10 days.

Next date of the hearing shall be communicated by the Secretariat of the Commission.
