Heard the representatives of the Petitioner and the Respondent.

The Petitioner submitted that Respondent had granted Open Access permission for FY 2012-13 with terms and condition that Wheeling Charges and Wheeling Loss are not applicable as express feeder and bay has been created under DDF scheme and maintained by the Petitioner.

Petitioner further submitted that Open Access permission was renewed for FY 2013-14 with same terms and conditions. However, for FY 2014-15, the Respondent has renewed Open Access permission with terms and conditions for levy of Wheeling Charges and Wheeling loss.

The Respondent requested the Commission to grant some time to submit its Reply to the Petition.

Petitioner requested the Commission to allow him to pay Energy bill from next month charged by Respondent excluding amount of Wheeling Charges. Respondent also agreed to the same.

The Commission directed the Respondent to submit its Reply to the Petition within a week and not to levy wheeling charges till the next hearing in the matter.
