Heard the Advocates of the Petitioner and the Respondent.

The Commission observed that MPECS has not provided copy of asset register and ASCI report to MSEDCL inspite of Commission's direction in its Daily Order dated 20 October, 2015. Also, MSEDCL has not provided the details of the amount deposited by it with the Commission to MPECS. MSEDCL is yet to submit the list of MPECS' asset being used by it. Further, inspite of Commission's directions to file submission within two weeks time, there is no submission from both the parties on the methodology for asset valuation.

The Commission thus observed that both parties have failed to comply with the directions given in the Daily Order dated 20 October, 2015 and attempted to justify the non-compliance citing unacceptable reasons. The Commission expressed its displeasure over the non-compliance of its earlier Daily Order and stated that the directions were given after hearing both the parties and such non-compliance is not acceptable. Both parties assured that they will implement the directions of the Commission.

Both parties sought ten days time to submit the suggestions regarding methodology for asset valuation with the necessary justification. Further, MSEDCL sought 3 weeks time for submitting the list of MPECS' assets being used and not used by it.

The Commission granted the request of the parties for making the above submissions. The Commission directs both the parties to submit the compliance of Daily Order dated 20 October, 2015 within 10 days.

Next date of hearing will be communicated by the Secretariat of the Commission.
