Daily Order

Heard the Advocate of the Petitioner and Representative of Respondent.

Advocate of MADC stated that the Commission in its Daily Order dated 18 November, 2014 issued in Case No. 149 of 2014 has allowed MADC to procure power on short term basis for supplying to its consumers and levy tariff of Rs. 4.386 per unit, which was less than the Ceiling Tariff i.e. MSEDCL's Tariff. Subsequent to above Order of the Commission, from 22 November, 2014, MADC has started supplying power to its consumers. During the period of

November 2014 to May 2015, MADC has procured the power from Power Exchanges (Rs 3.26 to Rs. 3.28 per unit) and from Lloyds (Rs. 3.50 to Rs 3.90 per unit). From June 2015 onwards, power is being procured from MSEDCL at Rs. 3.15 per unit. Purpose of present Petition is to update the status of power procurement and also for permission to continue power procurement on short term basis and levy a tariff which is lower than the ceiling Tariff.

While replying the Commission's query regarding time period for which such temporary arrangement needs to be continued, Advocate of MADC submitted that the dispute between MADC and AMNEPL on Concession Agreement is yet to be settled and will require some more time.

Representative of AMNEPL submitted that it has received a copy of Petition yesterday, and hence sought time to submit its say. The Commission allowed one week time for the same.
