## **Daily Order**

Heard the Advocates of the Petitioners and the Respondents.

Advocate for the Petitioners submitted that District Collector, Jalgaon has dismissed the Petitioners' claim of compensation citing no jurisdiction as per Indian Telegraph Act, 1885. As per the provisions of Section 67(3) of EA, 2003 and Rule 13 of Maharashtra Electricity Works of Licensees Rules, 2012, the District Collector is the competent authority for determination of compensation. Section 174 of EA, 2003 has overriding effect over the Indian Telegraph Act 1885. The Petitioner quoted Section 2 (1) (b) (i) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 wherein land acquisition proceedings are made applicable for Transmission Line Works. Petitioner's land is affected by the Transmission works and its use permanently restricted, which has resulted in diminution of value of property. He requested to remand the matter to the District Collector, Jalgaon for determination of the land compensation.

Advocates for MSETCL stated that adequate compensation has been paid to eligible affected farmers at the time of execution of work and filed its written submissions.

In Case No. 28 of 2016, MSETCL has erected tower on the land of Petitioner No. 6 (Shri Dhondu Panchu Pardeshi) only. No towers are erected on the other Petitioners' land; hence they are not entitled for compensation. Hence, on ground of false representation, the Case is liable to be rejected.

The Case is reserved for Order.
