Heard the Representatives of the Petitioner and the Respondents.

Representative of the Petitioner re-iterated the submissions as stated in the Petition. MSEDCL has not given the benefit of the Yantramag Sanjivani scheme, and the interest and delayed payment charges (DPC) have also not been waived from the bills of the Petitioner. He stated that the Petitioner will not press for his others prayers except for waiver of interest and DPC.

Representative of MSEDCL stated that it has complied with the CGRF Kolhapur's Order. The benefit of the Yantramag Sanjivani scheme has been given to the Petitioner, and interest and DPC have also been waived from his bills. The consumer was called for a meeting on 15 July, 2016 at MSEDCL's Vadgaon Office to understand the calculations, but did not attend. Hence, MSEDCL, vide letter No. Dy. EE/ Vadgaon/ 2636 dated 16 July, 2016, communicated to the consumer as well as the CGRF, Kolhapur that it has been complied with.

The Commission suggested that the Representative of the Petitioner may sit with MSEDCL's Officers to understand the calculations, that the parties submit the report to the Commission within two weeks.
