Daily Order

Heard the Advocates of the Petitioners and the Respondents in Case No. 130 of 2016 and 129 of 2017.

As both the Cases are filed for review of the same Order (i.e. Additional District Collector, Nashik's Order dated 16.12.2015) and involve the same parties, the Commission clubbed the proceedings in Case No. 130 of 2016 and, 129 of 2017 with the consent of the parties.

At the hearing, Advocate of MSETCL submitted that it has not received the copy of the Petition in Case No. 129 of 2017 and hence requested the Commission to direct the Petitioners to serve a copy of the Petition. He also sought two weeks time to file its Rejoinder in Case No. 130 of 2016.
