- 1. The Commission observed that, during the last hearing on 3 August, 2017, MBEDA was directed to implead all the Distribution Licensees, viz. BEST, TPC-D & RInfra-D, besides MSEDCL, and serve a copy of its Petition to them. All the Distribution Licensees were asked to file their Replies within two weeks, and MBEDA was asked to file its Rejoinder, if any, within 10 days thereafter.
- 2. MBEDA stated that it has served all the Distribution Licensees, but has not received any Replies. The Commission notes that MSEDCL had already filed its Reply dated 27 July, 2017 and MBEDA has filed its Rejoinder dated 21 August, 2017. MBEDA requested the Commission to take a sympathetic view on its Petition.
