Daily Order

- 1. The Parties were informed that the Commission has resolved that the matter will be heard and decided by a two Member Bench.
- 2. The Commission heard the representative of the Petitioner and the Respondent.
- 3. Representative of the Petitioner stated that the Petition seeks compliance of the Commission's Order dated 8 July, 2016 in Case No. 147 of 2015 regarding refund of the differential amount on account of change in Tariff category from Continuous Industry to Non-continuous Industry. Subsequently, MSEDCL has refunded the differential amount and the Commission's Order has been complied with by

MSEDCL. However, no interest has been paid by MSEDCL. Also, the other consumers namely, M/s. Prerana Magasvargiya Co-Op. Industries Ltd., M/s. Satyasai Co-Op. Industries Ltd. and M/s. Pratibimb Magasvargiya Co-Op. Industries Ltd. are not in the list of consumers whose Applications are being processed by MSEDCL for refund.

- 4. Representative of MSEDCL stated that the refund has been given to the Petitioner. Interest has not been provided since no such direction had been issued in the Commission's Order dated 8 July, 2016 in Case No. 147 of 2015.
- 5. The Commission observed that the Petitioner's grievance has been addressed, barring the issue of interest. However, as informed by the Petitioner, there are other consumers having the identical grievance covered in 8 July, 2016 Order. The Petitioner may submit the relevant details within a week with a copy to MSEDCL, so that MSEDCL can take appropriate steps for those eligible consumers on the refund issue also and they do not have to approach the Commission seeking refund of the differential amount.
