DAILY ORDER

Heard the Advocates/Representatives of the Petitioners, Respondents and Consumer Representative.

- 1. The Representative of Sun N Sand Hotels Private Limited (SSHPL) stated that:
- 1.1 The Commission in its Order dated 16 March, 2017 has directed MSEDCL to pay the DPC amounts due within 30 days, thereafter an interest at the rate 1.25% per month would accrue on any Delay Payment Charges (DPC) amount remaining to be paid.
- 1.2 MSEDCL has not complied with the Commission's Order dated 16 March, 2017. MSEDCL in its submission dated 30 December, 2017 stated that Rs. 1.56 crore has been released in December, 2017. MSEDCL has not given any accounts statement for the amount released.

- 1.3 MSEDCL has not paid Principal and Delay Payment Charges (DPC) as directed by the Commission. About Rs. 10 crore is still remained to be paid to SSHPL.
- 2. The Representative of MSEDCL stated that:

MSEDCL has paid to SSHPL Principal amount of Rs. 14.21 crore since September, 2016 to July, 2017. Further, it has released Rs.1.56 crore in December, 2017 along with DPC. The current outstanding amount is Rs. 0.91 crore.

3. The Commission directs both the parties to sit together and reconcile the statement of account and submit the report within two weeks.
