### **Daily Order**

At the outset, the Commission informed the Parties that the Interlocutory Application in Case No. 175 of 2017 filed by SWPGL was heard by two Member bench (Chairperson and Member –Deepak Lad), the present main Petition is also being heard by the same bench to which Parties agreed.

Advocate of the SWPGL stated that it has received MSEDCL's reply on 15 January, 2018 and it has also received TPC-D's and MSLDC's replies yesterday. Hence requested for adjournment of the hearing and sought two weeks' time to file its Rejoinder.

MSEDCL objected to the adjournment on the ground that its past history shows that the Petitioner is in habit of seeking adjournments. It has no objection to adjournment if it is decided by the Commission but the Petitioner should argue the matter on the issues raised in the Main Petition as it may raise new issues through its Rejoinder.

The Commission expressed its displeasure as SWPGL has sought adjournments in past and also in the instant Case sought adjournment one day prior to the hearing.

As requested, the matter is adjourned for two weeks. The next date of hearing shall be communicated by the Secretariat of the Commission.
