Daily Order

Heard the Representatives of the Petitioner.

Representative of the Petitioner submitted that:

- i. KRC Infrastructure and Projects Pvt. Ltd. (KRC) and M/s Gera Developments Pvt. Ltd. (jointly) have been notified as the developer for IT & ITeS SEZ at Survey Nos. 65(1), 65(2) and 65(3), Village Kharadi, Taluka Haveli, District Pune.
- ii. Under Section 14(b) of the Electricity Act, 2003, KRC is deemed to be a Distribution Licensee for the notified SEZ area admeasuring 4.03 Hectares which has been subsequently revised to 4.92 Hectares vide notification S.O. 1832 (E) dated 26 April, 2018. The map certified by the concerned SEZ authorities is yet to be received. KRC shall submit it as soon as same is received.

- iii. The Joint Developer, M/s Gera Developments Pvt. Ltd., has issued the No Objection Certificate (NOC) for KRC becoming the Distribution Licensee and to undertake the power distribution business in the SEZ area.
- iv. KRC requested the Commission to take on record its deemed Distribution Licensee status for the above SEZ and issue the Specific Conditions of Distribution Licence applicable to KRC.
- v. At present, there is no Power Purchase Agreement or arrangement in place for KRC and the tariff to be charged to the consumers has also not been approved by the Commission. Till such approvals are in place, KRC may be allowed, in the interim, to charge its consumers, the tariff that is applicable for the respective category of consumers in the MSEDCL's area of supply, as the 'ceiling Tariff' in its area of supply.

The Commission directed KRC to submit the map, duly certified by the Development Commissioner (SEZ), indicating the revised SEZ area within 10 days.
