DAILY ORDER

Heard the Advocates/Representatives of the Petitioners, Respondents.

The Commission observed that, since similar issues have been raised in these Cases by Wind Energy Generators, they would be heard together, and the Commission would also consider a common Order. The Parties agreed.

1. The Advocate represented both the Petitioners viz. M/s. Classic Marble Company Private Limited and M/s. Relishah Export stated that MSEDCL has not paid outstanding principal

amount against invoices raised in November 2017 and outstanding Delay Payment Charges (DPC) due up to January, 2018. The Commission is requested to direct MSEDCL to comply with the terms of EPA and provide dispensation as issued in the similar cases for other Wind Generators.

- 2. The Advocate of MSEDCL stated that it requires 30 days time to reconcile the statement of outstanding principal and DPC amount.
- 3. The Commission observed that for similar types of issues, Wind Generators in the past and now also, are approaching the Commission for settlement of the long pending dues in respect of principal and DPC amount. The Commission directs MSEDCL to work out a time bound mechanism to clear outstanding claims in consultation with the generators, and submit it to the Commission within 6 to 8 weeks.
