1. The Petitioner reiterated its submission of the Review Petition and stated that:
 - a) Approve the actual equity instead of proportionality reduced equity for its new Projects (Koradi Units 8, 9 and 10, Chandrapur Units 8 and 9 and Parli Unit 8).
 - b) Approve the Auxiliary consumption norms for Koradi Units 9 & 10 and Chandrapur Units 8 & 9 in accordance with the MERC, MYT Regulations, 2011 i.e. 6% instead of 5.25% which is revised in the MERC MYT Regulations, 2015.

2. Representative of MSEDCL stated that it will file its written submission within a week.
3. On the query of the Commission about the grounds to Review of the impugned Order and issues raised which are already been decided. MSPGCL stated that the due to delay in commissioning of these Units the IDC has been already deducted and due to this it will be continued effected for next 25 years.
4. Prayas (Energy Group) an Authorised Consumer Representative vide its email dated 1 July, 2018 stated that, it will file a written submission to further elaborate the points raised by the Petitioner. It requested the Commission to allow us to make further submissions in this matter.
5. The Commission directs MSEDCL and Prayas (Energy Group) to file their replies on the Petition by 4 July, 2018 with copies to the other parties.
