- 1. Representative of the Petitioner stated that its Case was mentioned before the Commission on 11 April, 2019. Subsequently, Hon'ble the Appellate Tribunal for Electricity (APTEL) in appeal filed by Association of Power Producers (DFR No. 1762 of 2019) had passed an interim Order on 15 April, 2019 wherein it had directed Maharashtra State Load Despatch Centre (MSLDC) not to implement the Merit Order Despatch (MOD) Guidelines issued by the Commission on 8 March, 2019 till the next date of hearing, which is scheduled on 2 May, 2019.
