1. Heard the representatives of Petitioners, Respondents and Impleaded Parties in their respective Cases.

- 2. On the issue of provisional FCR methodology, the Commission observes that MSPC/MSLDC as per Daily Order dated 6th February 2019 was required to decide on the interim methodology to be followed for recovery of provisional fixed charges bills after considering the views/ comments of members. These activities were to be completed by MSPC within 10 days.
- 3. In the absence of any submission on the interim methodology for recovery of provisional fixed charges bills by MSPC, the Commission directs MSLDC to submit its proposed interim methodology/principles for recovery of provisional fixed charges bills along with supporting relevant information and assumptions to the Commission within seven days for consideration of the Commission. MSLDC may share such proposed interim methodology/principles for recovery of provisional fixed charges bills with members of MSPC.

Next date of hearing will be informed by the Secretariat of the Commission.
