Heard the Advocates of the Petitioner, Impleaded Respondents and Applicants for Intervention in Case No. 86 of 2019.

1. Advocate appearing on behalf of the Applicants for Intervention stated that they are necessary parties to be impleaded in this matter as on the Petition filed by these Applicants, the Commission has initiated an Enquiry of M/s. Global Energy Pvt. Ltd. and their Application for Intervention may be treated as suggestion/ objection to the Petition of M/s. Global Energy Pvt. Ltd. for surrender of its Trading Licence.
2. Advocate for Chalet Hotel (Respondent) stated that they have received the copy of Petition only on 15 May, 2019 and need time to reply. Hence, the matter may be adjourned. Similarly Advocate for Modern India Ltd. (Respondent) sought time to file the reply stating that the Petition was received by them only on 16 May, 2019.

3. Advocate for Global Energy Pvt. Ltd. objected to the impleadment of various Parties as well to the application for intervenors filed by POSCO Maharashtra Steel Pvt. Ltd. and Siddhayu Ayurvedic Research Foundation Pvt. Ltd. seeking impleadment in the matter and stated that it will be filing its objection within seven days.
4. The Commission directs Global Energy Pvt. Ltd. to make its written submission on objections to the impleadment of Parties within seven days. The impleaded Respondents are directed to file their replies to the Petition within seven days thereafter.

Next date of hearing will be informed by the Secretariat of the Commission.
