1. Heard the Advocates for the Petitioner, Respondents, Impleaded Parties (MSLDC and MSETCL) and Intervenors on the issue of impleadment of Captive users indeclaration of Captive Generation status of its Generating Units of Sai Wardha Power Generation Limited (SWPGL) for FY2016-17 (25 Captive users) and FY 2017-18 (29 Captive users).

2. TPC -D has filed Application for impleadment that all the Captive users / Shareholders of SWPGL shall be impleaded in the both the Cases. Other 7 Intervenors, who are Captive users / Shareholders, have also filed independent application to allow them to be impleaded in both cases of captive status declaration.
3. On hearing the Parties, the Commission allows the impleadment of the all Captive users / Shareholders in both Cases regarding declaration of Captive Generation status of Generating Units 3 and 4of SWPGL for FY 2016-17 and FY 2017-18.
4. The Commission further directs Petitioner, Respondents and Impleaded Parties to serve the copies of all their submissions alongwith annexure on the all Captive users / Shareholders of SWPGL within a week and Captive users / Shareholders shall file their submissions, if any, within two weeks, thereafter with copy to all the Parties (Petitioner, Respondents and Impleaded Parties) in the matter.
5. The Petitioner and Respondents shall furnish the detail address of all Captive users / Shareholders and also the acknowledgement about the submissions that have been served to them.

The next date of hearing shall be communicated by the Secretariat of the Commission in Case No. 175 of 2017 and Case No.170 of 2018.
