### **Daily Order**

Advocate Mr. Anup Jain of MSEDCL (Respondent) vide e-mail dated 06 May 2021 informed the Office of the Commission that he has been tested positive for Novel Coronavirus (Covid-19) and hence requested for adjournment in the listed matters.
