Daily Order

- 1. Heard the Advocates of the Petitioners and Respondent.
- 2. Advocates of Petitioners stated that in spite of explicit directives of the Commission in its Daily Order dated 1 December 2020, MSEDCL has not specified timelines for clearing dues of Wind Energy generators. Further, MSEDCL has made an additional submission on evening of 14 June 2021 quoting Covid-19 pandemic scenario for non-adherence of contractual obligations under EPA and has refused to commit for specific timelines for payment of outstanding dues. It has also brought to the notice of the Commission that even though some amount towards principal and DPC has been paid but interest on DPC amount has not been paid. All advocates have requested the Commission to keep this matter pending till MSEDCL gives a specific commitment for payment timelines and further the mechanism for regular payment of dues to ensure that the Generators are not required to approach the Commission again and again. It was also pointed out that MSEDCL's payment claims.
- 3. Advocate of MSEDCL submitted that due to Covid-19 pandemic situation, its revenue stream has been greatly disturbed. In such situation MSEDCL is striving hard to find out ways to fulfil its contractual obligations. Advocate of MSEDCL presented a statement of arrears settlement with respect to Petitioners in the present matters. In reply to Commission's query regarding regular process for reconciliation of dues, Advocate of MSEDCL assured that the issue will be discussed with concerned officials for setting up such process so that payable amount is reconciled regularly.

4. Having heard the parties, the Commission notes that many wind generators are approaching with request to direct MSEDCL for payment of their dues. Being contractual obligation, MSEDCL is bound to pay such dues. At the same time, the Commission is also aware of MSEDCL's disturbed cashflows in current pandemic situation. In such circumstance, MSEDCL should devised a plan in consultation with wind generators for settlement of their dues in timebound manner and regular payment of current bills. MSEDCL shall also consider other options of collaborative and supportive participation of generators for early monetization of arrears amount. They shall submit such timebound plan within two weeks from the date of this order and shall serve a copy on all the parties. Alongside, MSEDCL should also immediately share with the petitioners its statement of payments made as was presented during the hearing.

Subsequent to receipt of above submissions, Next date of hearing will be intimated by the Secretariat of the Commission.
