- 1. Advocate of SWPGL stated that he would require 10-days' time to submit the reply of the Data gaps/ clarifications raised by the Commission.
- 2. Advocate of MSEDCL stated that as MSLDC had filed its reply yesterday, he would require additional time to file the reply.
- 3. Advocate of TPC-D sought for adjournment of hearing due to personal difficulties of their arguing counsel.
- 4. Advocate for other Appellants before the Hon'ble ATE stated that they would require 7 days' time to file their submissions after the submissions were received from MSEDCL and TPC-D.
- 5. The Commission expressed concern that, as per the Hon'ble ATE Judgment dated 2 September 2021, the matter was required to be decided within three months, and hence, all the Parties should file their replies on time and no further adjournment would be given in the instant matter.
- 6. Considering the submissions of the Parties, the Commission accordingly directs as under:

- (iii) All the Captive Users of SWPGL for FY 2018-19 /Appellants and SWPGL to file their respective submissions and Rejoinder, if any within 7 days thereafter.

After the receipt of submissions from Parties as above and as per the time frame decided by the Hon'ble ATE Judgment dated 2 September 2021, the Secretariat of the Commission will communicate next date of hearing.

In view of the time limit to decide the case no further adjournment shall be granted.
