Heard the Advocates of the Petitioners and Respondent.

In reply to the query of the Commission regarding detailed computation of outstanding principal amount and Late Payment Surcharge (LPS) claimed in the Petitions, Advocates of the Petitioners sought time of 3 days for filing such details.

The Commission opined that once Petitioners submits such detailed computation and MSEDCL responds to the same, these matters could be heard holistically on the issue of determination of outstanding amount and other legal issues raised in the petitions, on next date of hearing. All parties agreed to the same. However, Petitioners requested that in the meantime MSEDCL could be asked to release some part payment of outstanding amount, it would greatly help petitioners tide over to some extent difficult financial situation being faced by them.

Advocate of MSEDCL stated that in other similar matters it had already submitted payment plan for payout by 31 December 2021 to all Wind Generators of Principal dues that had accrued up to generation month of December-2020. MSEDCL will adhere to the same while settling the claims of petitioners as per the time line mentioned in the payment plan. Further, Advocate of MSEDCL requested 10 days' time post receipt of claim details from the Petitioners, for filing its reply.

Considering the above submissions, the Commission directs the Petitioners to provide the computation details of generation month wise outstanding dues along with LPS liability within three days to the MSEDCL. Thereafter, MSEDCL shall file its reply on the same within 10 days. Further, parties shall ensure to file their note of arguments one day in advance before next date of hearing.

Next hearing in these matters is scheduled on Friday, 12 November 2021.
