Heard the advocates of the Petitioner and Respondent.

Advocate of Petitioner submitted that MSEDCL's Reply to the Petition has been received two days back i.e. 27 October 2021 and hence he requested 4 weeks' time for filing Rejoinder. He further stated that MA No.26 of 2021 was filed seeking directions to MSEDCL to return the CWPPL's original Performance Bank Guarantee (PBG), as it has furnished the Demand Draft of equivalent amount with MSEDCL. Subsequent to filing of such MA, MSEDCL has retuned the PBG on 1 October 2021. Hence, MA 26 of 2021 becomes infructuous and may be disposed of.

Advocate of MSEDCL concurred with the request for adjournment.

Considering the requests made by Petitioner, the Commission allows it to submit Rejoinder on submission made by MSEDCL within 4 weeks with copy served on MSEDCL. Also, MA No. 26 of 2021 stands disposed of as it becomes infructuous for the reasons stated above.
