Shri. Tarak Oza has submitted a Petition, under affidavit before the Commission on 09.08.2012, for Review of Order dated 15.06.2012 passed in Case No.180 of 2011. The prayers of the Petitioner are as under-

- a) *That the order dated 15.06.2012 be reviewed;*
- b) *That MERC should be pleased to re-determine Cross-Subsidy Surcharge in a manner and fashion that there is no discrimination in levy of Cross-Subsidy Surcharges viz-a-viz for Reliance consumer and or to Tata Consumer and that in the interest of justice, equity and fair play, the Petitioner and other like consumer of Reliance are not forced/compelled to pay higher Cross-Subsidy Surcharges;*
- c) *That MERC increase the tariff of Residential consumers of Reliance such that the cross subsidy payable by Commercial Consumers to them is not more than Rs.0.84 pu.*
