Adarsh Hatchery & Farm, have submitted a Petition under Section 142 and 146 of Electricity Act 2003, under affidavit on 01.02.2013, Petition for Non compliance of CGRF Kalyan Order No. K/E/585/693 dt. 19.03.2012. The following are the main prayer of the Petitioner -

- “ a) *Invocation of section 142 & 146 of Electricity Act for non compliance of CGRF order, E.A. 2003 & non implementation of ACT, Rules & Regulations.*
- b) *Re-instant our original category of LT IV Agriculture & revise our bills from Aug'11 to November 2012.*
- c) *Excess amount lying with MSEDCL may be refunded or adjusted in our bill along with interest as per sec 62(6)of EA 2003, which is 9.5% as declared by MSEDCL on their Security deposits vide cir. No 175 dt. 5.9.2012.*
- d) *As per EA 2003 sec 56 (1) we are paying our regular monthly consumption bill & matter is under dispute, Disconnection of supply will not be made.*
