Subject: Petition of MSEDCL for for extending the applicability of TOD rebate beyond March 2013.

- Case No. 42 of 2013

MSEDCL, have submitted Miscellaneous Application on affidavit 22.03.2013. for extending the applicability of ToD rebate beyond March 2013.with Annexure, as per the Order dated 26th Dec 2012 in Case No.107 of 2012. The main prayers of the Petitioner are as under-

1. *To admit the Miscellaneous Application and to take up the same for expeditious hearing;*
2. *To permit MSEDCL to continue the enhanced TOD rebate from 100 paise per unit to 250 paise per unit as applicable to all such consumers who are otherwise eligible for TOD rebate; for a further period of six months i. e. up to September 2013;*
3. *To pass any other order as the commission may deem fit appropriate under the circumstances of the case and in the interest of justice;*
4. *To condone any error/ omission and to give opportunity to rectify the same;*
5. *To permit MSEDCL to make further submissions addition and alteration to this Miscellaneous Application as may be necessary from time to time.*
