MSEDCL has submitted a Petition under affidavit on 01.03.2013, for Additional amount payable to MSPGCL and in the matter of Order dt 8.02.2013 in Case No. 77 of 2012, Petition filed by MSPGCL seeking review of Order dt 21.06.2012 in Case No. 6 of 2012. The main prayers of the Petitioner are as under-

1. *To permit the petitioner to defer payment of Rs 143.12 Crs to MSPGCL till such time appropriate mechanism for recovery of the same from its own consumers is approved by the Hon'ble Commission*
  2. *To Permit the petitioner to refund the said amount only after an equivalent amount is recovered from the consumers of the petitioner*
  3. *To determine in exercise of powers conferred to the Hon'ble Commission in accordance with the Section 62 of Electricity Act 2003 an additional charge to be recovered from the consumer of the petitioner to compensate to the said additional burden of Rs 142.12 Crs.*

3.
