Subject: Petition of Wardha Power Company Ltd.for wrongful imposition of Cross Subsidy Surcharges (CSS) by the MSEDCL on the captive consumers of Wardha Power Company Ltd. availing Open Access .MA No 5 of 2013 is given to the said application

Misc Application No 05 of 2013 in Case No. 117 of 2012

Wardha Power Company Ltd has filed a miscellaneous application (Misc Application No. 5 of 2013) on 08 March in Case No 117of 2012 in the matter of wrongful imposition of Cross Subsidy Surcharges (CSS) by the MSEDCL on the captive consumers of Wardha Power Company Ltd. availing Open Access. The main prayers of the said Misc Application are as under.

(a) stay the operation of the invoices issued by the Respondent No. 1, for the power sourced by the Petitioner to the captive user in the month of February 2013,as mentioned in paragraph 10 of the present application..

(b)direct the Respondent No. 1 to not to take any coercive action whatsoever, in terms of the letters as mentioned in paragraph 10 of the present application.

(c) direct the Respondent No. 1 that it cannot impose CSS pending disposal of the main Petition.

(d) quash the invoices raised by the Respondent No. 1 (as mentioned in paragraph 10 of the present application), containing imposition of CSS ,for the power sourced by the Petitioner to its captive user for the month of February 2013, and further direct the Respondent No. 1 to issue fresh invoices/ bills without the levy of CSS

(e) pass such other and further orders as this Hon'ble Commission deems fit and proper under the facts and circumstances of the present case.

2. I am directed to communicate that a hearing in the matter will be held in the presence of authorised consumer representatives on **Thursday, 25 April, 2013 at 11.00 hrs** in the office of the Commission at 13th Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

3. The Petitioner is directed to serve a copy of its above mentioned Misc. Application, dated 08 March, 2013, along with its accompaniments, (both soft and hard versions) to the Respondents and authorised consumer representatives immediately, whose addresses are given below.

4. I am directed to further communicate that the Commission has directed, that no coercive action should be taken by MSEDCL before the matter is heard by the Commission on the scheduled date of hearing i.e 25 April 2013
